The manner, place and time of opening of bids: The public opening of bids will be conducted on the day 21. May 2018. at 12:30 pm by the Commission for public procurement, in the premises of the Contracting Authority at the address Kralja Milana 36, Belgrade, I. floor, Conference Room.

The Bidders' representatives who participate in the public opening must submit before the opening of the Public Procurement Commission a written power of attorney (authorization) issued on the letterhead of the bidder, sealed and signed by an authorized person.

The deadline for making a decision on awarding the contract: the contract award decision Contracting authorities shall issue pursuant to Article 108, paragraph 2 of Law on Public Procurement.
